Chairperson/President's Report

2022 was an exciting year for WyHy with two successful mergers (Wyochem and Sweetwater). WyHy ended 2022 on a high note—WyHy ended the year with \$362,278,075_in assets, \$318,187,144 in shares, and \$289,402,721 in loans. At year-end, there were 22,232 members, served by 59 employees in the Casper, Cheyenne, and our new Green River, Rock Springs, and Lyman branches.

Supervisory Committee Report

The Supervisory Committee is appointed by the Board of Directors and is given the responsibility of reviewing and evaluating operations to ensure WyHy's records are complete and correct. The work of the committee verifies that transactions are recorded properly and the assets are secure. The Committee consists of volunteer members and meets once a month to conduct and review audits, as well as respond to member complaints.

Due to the size of WyHy's operations and the variety of services offered, the Supervisory Committee retains the firm of Petersen and Associates to conduct the required agreed upon procedures and engagements. These include three interim engagements and an annual opinion audit.

Community Service

WyHy has continued its commitment to supporting not just our members, but the communities we're located in. We accept requests for donations and sponsorships from members and the general public and review those requests on a monthly basis. We donate financial resources as well as our time and talents.

During 2022, we supported 25 charities and groups spread throughout Wyoming, donating more than \$40,000 to help support Wyoming communities. Some of those charities include: Cowboys against Cancer, United Way of Laramie County, Meals on Wheels, Habitat for Humanity, Food Bank of the Rockies, Needs Inc., and Climb Wyoming
