

WYHY FEDERAL CREDIT UNION GET OUT THERE RV & AUTO LOAN SWEEPSTAKES

1. Eligibility: WYHY FEDERAL CREDIT UNION GET OUT THERE RV & AUTO LOAN (the "Sweepstakes") is open only to those who apply and get approved for (the "entry") a WyHy Federal Credit Union RV, Motorcycle, Boat or Vehicle Loan, who are 18+ years old and a member of the Credit Union as of the date of entry, and are new loans to the Credit Union (existing WyHy Federal Credit Union loans, or any other product or service a member may have with WyHy Credit Union is not eligible for this Sweepstakes). The sweepstakes is only open to legal residents of the United States and is void where prohibited by law.
